Scott Parent:

Mr. Parent is advocating for solutions that meet interests of residents pertaining to the new parking restrictions on the block of 4200 Oriole. Mr. Parent shared the impact of residents whose homes face Giles School. He voiced his concerns on parking issues and snow removal issues. Mr. Parent proposed to find a solution for all involved, residents and Giles School.

Sarai Barrios:

Ms. Barrios has concerns about her tree and wanted to voice her complaint of a Village employee. Ms. Barrios voiced her concerns and opinions of the new parking signs that went up on the block of 4200 Oriole. Ms. Barrios asked why signs were put up without working with residents.

Cynthia Barrios:

Ms. Barrios voiced her complaint and misconduct of Village employee and requests to remove a tree in front of her house. Ms.Barrios shared her concerns with the new resident parking signs and restrictions.

Stacey Jones:

Ms. Jones voiced her concerns about the recent parking restrictions and petitions to remove the parking signs. She mentioned she was disappointed on how the process was communicated to the residents.

Rosemary Maurello:

Ms. Maurello voiced her concerns regarding the new parking restrictions. She has concerns regarding parents picking up kids from school and resident parking.

Frank Tribuzio:

Mr. Tribuzio voiced concerns of parking that is needed for teachers, administration, nurses, parent visits, lunch workers, service techs, volunteers and employment candidates.

Michelle Guzik:

Ms. Guzik stated she has been with the district for 31 years as is the Superintendent of District 80. She stated she reached out to President Tannhauser regarding parking issues at Giles School and wanted to have a discussion to come up with a solution. Giles maintains the snow removal and paving issues. She mentioned that on street cleaning days residents park in spaces by the school and teachers do not have anywhere to park. She would like to have a good discussion regarding parking issues and safety of the children.

Discussion was had by Village Board and residents to discuss an Ordinance Enacting Certain Parking Restrictions Adjacent to Giles School on School Days for the East Side of N. Oriole Avenue Running 294 Feet South from the Stop Sign at the Intersection of N. Oriole and W. Cullom Avenues.
