Kucharski, Tannhauser, Sulimowski, Falagario, Gregorio Yea. Nays none. Motion carried. Trustee Gelsomino was not present at the last board meeting therefore did not vote on the approval of the minutes from July 26, 2017.

FINANCE, LICENSES & CONTRACTS, Trustee Gregorio:

Trustee Gregorio had no discussion items. She asked if there were any questions in regards to her consent agenda. There were none.

Motion by Gregorio, seconded by Kucharski to:

- (a) Accept ACH payment from the Illinois Comptroller's Office, dated June 6, 2017, in the amount of \$358,332.09 for the Village's share of Sales Tax.
- (b) Accept ACH payment from the Illinois Comptroller's Office, dated June 6, 2017, in the amount of \$372,448.58 for the Village's share of Home Rule Sales Tax.
- (c) Accept ACH payment from the Illinois Comptroller's Office, dated June 7, 2017, in the amount of \$146,276.87 for the Village's share of Income Tax.

- (d) Accept ACH payment from the Illinois Comptroller's Office, dated June 14, 2017, in the amount of \$29,578.77, for the Village's share of Telecommunications Tax revenues.
- (e) Accept ACH payment from the Illinois Comptroller's Office, dated June 15, 2017, in the amount of \$32,639.27 for the Village's share of Use Tax.

LAW & ORDINANCE & ECONOMIC DEVELOPMENT, Trustee Falagario:

Trustee Falagario had no discussion items to review. He asked if there were any questions in regards to his consent agenda. There were none.

Motion by Falagario, seconded by Tannhauser to:

- (a) Adopt and approve Ordinance No. 1901-17, "AN ORDINANCE AMENDING CHAPTER 6, ARTICLE II, DIVISION 2, SECTION 6-44 OF THE REVISED MUNICIPAL CODE OF THE VILLAGE OF NORRIDGE 2002: An Ordinance Increasing the Number of B Liquor Licenses."
- (b) Adopt and approve Ordinance No. 1902-17,"AN ORDINANCE GRANTING A VARIATION FROM LIMITATIONS OF THE REQUIREMENTS OF THE 1962 ZONING ORDINANCE OF THE VILLAGE OF NORRIDGE, COOK COUNTY, ILLINOIS FOR THE PROPERTY COMMONLY KNOWN AS 7015 WEST AGATITE AVENUE: An Ordinance Granting Variations From the Requirements of the Zoning Ordinance Article IV, Section 3, Lot Coverage and Green Space Area."
- (c) Approve the addition of one Class A liquor license for the AMC Theatres Norridge located at 4520 N. Harlem Avenue, subject to the satisfactory completion and passing of a background check on the store manager, and instruct the Village Attorney to prepare the necessary ordinance.
- (d) Refer the petition of Dan Kidd, requesting variations from the requirements of Article IV, Section 2.2 Two Story Structures and Article IV, Section 3.1(e) Lot Coverage and Green Area of the Zoning Ordinance of the Village of Norridge 1962 for the purpose of constructing a two story single family residence on the property located at 4032 North Ottawa Avenue, to the Zoning Board of Appeals for a Public Hearing on September 11, 2017 and their recommendation to the Village Board.

CELL PHONES, CELL SITES and ELECTRICAL AGGREGATION, Trustee Sulimowski:

Trustee Sulimowski had no discussion or consent agenda items for review.

POLICE. Trustee Kucharskí:

Trustee Kucharski announced the retirement of Sergeant Louis P. Orlando III from the Norridge Police Department after 36 years of service. She asked Sergeant Orlando to come to the front of the board room to receive a plaque of appreciation from President Chmura, Trustee Kucharski and the Village Board.

Sergeant Orlando thanked the board for the recognition. He mentioned both his parents especially his father who before passing away had not called in sick in 25 years at his job. In 36 years Sergeant Orlando has never called in sick, was never injured on the job and was never sued. These situations happen to police officers. Sergeant Orlando is proud to have avoided all of them. Sergeant Orlando's retirement date is August 15, 2017.

Trustee Kucharski asked if there were any questions in regards to her consent agenda. There were none.

Motion by Kucharski, seconded by Gregorio to:

- (a) Accept letter dated July 26, 2017 from Commander Wayne Schober and concur with his recommendation that David Las be appointed as a Probationary Auxiliary Police Officer, effective August 16, 2017, at a rate of \$16.00 per hour. He will serve a one year probationary period which will begin at the end of his training period.
- (b) Enter into an Intergovernmental Agreement with Major Case Assistance Team for the purpose of enhanced law enforcement capabilities by having access to regionalized facilities, programs and the assistance of other departments. The agreement shall become effective immediately upon execution and remain inforce unless a resolution is adopted terminating participation.

Odell Avenue and, if approved, to refer the matter to the Law and Ordinance and Economic Development Committee for preparation of the necessary amendatory ordinance.

COMMENTS FROM THE PUBLIC:

Frank Lombardo

Mr. Lombardo commented on the Public Works Department. On behalf of himself and his neighbors on Ozanam he commended the department for their efforts after the storm on Aug. 3, 2017. He called the village regarding tree branches that had fallen and trees that continued to look like they would cause some danger.
