Hearings: Case # 621 – 7015 W. Agatite

The letter from the petitioner was read by Secretary Budnik.

The Chairperson opened the hearings by reading the rules and having all attendees sworn in.

To consider a petition requesting variances under the requirements of Article IV, R-1 Single Family Residence District, Section 3-Area Regulations, Subsection 3.1(e) – Lot coverage and green area requirements of the Zoning Ordinance of the Village of Norridge – 1962 to increase the lot coverage from the required 45% to 47.79% and to reduce the green space from the required 35% to 30.76% to construct a 20' x 20' x 14' garage on the following described property:

LOT SEVEN (7) IN BLOCK FOUR (4) IN HARLEM AVENUE HIGHLANDS SUBDIVISION IN THE NORTHWEST QUARTER (1/4) OF SECTION 18, TOWNSHIP 40 NORTH, RANGE 13, EAST OF THE THIRD PRINCIPAL MERIDIAN IN COOK COUNTY, ILLINOIS, ACCORDING TO THE PLAT OF SAID SUBDIVISION REGISTERED MAY 21, 1924 AS DOCUMENT NUMBER 218267

The property is commonly known as 7015 W. Agatite in Norridge, Illinois.

The case was presented by the owner Mr. Myszka. He stated that he purchased the home 2 years ago and did not realize that there was not enough room for the required 2 car garage. He stated that he needed to remove 40 square feet of concrete beyond the garage.

The Board asked the following questions (Q) and answers (A) provided.

- Q: Stated that there are several single garages on the block and you have none. You have one of the four 60 foot long homes on the block. Will you put grass in place of the concrete you are removing?
- A: Yes
- Q: Will you be adding concrete for sidewalk to garage?
- A: Only what is there will remain.
- Q: What are your side yard setbacks for the garage?
- A: 3 feet and 7 feet.

Mr. Gaseor stated that the property would be over 2.79% of lot coverage and be short of green space.

- Q: Will there be gutters on the structure and if so will they be discharged to the alley?
- A: There will be gutters and I will discharge them to the alley.
- Q: Are you willing to remove additional concrete to bring concrete removal up to approximately 110 square feet to get closer to the green space needed number?

A: Yes

Visitors Comments: None

Board Discussion & Findings:

There were no discrepancies to note on the Findings.

Motion: A motion was made by Mr. Thompson seconded by Mr. Ronstadt to recommend to the Village Board to allow the increase of lot coverage from 45% to 47.79% and reduce green space from 35% to 30.76% (the 30.76% will increase with the below stated stipulation) to build a 20'X20'X14' garage and remove 110 square feet of concrete beyond the garage footprint.
