There is a house that is half built on the 5100 block of Monterey. It has been this way for the last 7 or 8 years. The property is an eye sore. Do permits expire? Were there inspections? How can the property sit that long in that condition? The same owner has a rental property next door to his home. He has reported to the village twice the poor conditions there. Grass is over grown. Painters hired to paint the home said they were painting over mold. It is disgraceful. Shouldn't these homes be regulated or inspected? He is not sure how someone gets away with the conditions he has left the homes in.
