LAW & ORDINANCE & ECONOMIC DEVELOPMENT, Trustee Falagario:

Trustee Falagario mentioned the Zoning Board of Appeals has recommended we GRANT the petition of Albert Bruno, requesting rezoning from B-2, restricted (Shopping Center) Business District to B-3, General Business District. This item is included in the consent agenda vote.

Mark Chester clarified the petition request and explained the current location is one structure which is zoned both B-2 and B-3. The petitioner asked to zone the entire structure B-3.
