#### **President's Report**

Park Ridge being one of them. They wanted to delay the vote. The vote prevailed and will now go to the FAA. Hopefully within the next year we will see changes to the rotation and noise.

# PUBLIC WORKS, WATER, TREE PROGRAM, PARKING, STREET LIGHT CABLE REPLACEMENT PROJECT: Trustee Tannhauser:

Trustee Tannhauser read the following news release:

(a) On November 14, 2017 the Village of Norridge released the following News Release:

Village of Norridge Replaces Street Lights through Energy Efficient Lighting Grants

Over the past 12 months, the Village of Norridge has been the recipient of rebate incentives awarded by the Illinois Department of Commerce & Economic Opportunity (DCEO) and the Com Ed Energy Efficiency Programs. Approximately \$200,000 awarded to the Village has allowed for the replacement of more than 200 outdoor street lights throughout the community. The outdoor lights retrofitted with LED energy efficient lighting is expected to result in an annual cost savings of approximately \$50,000 for the Village.

The Village of Norridge strives to set a high standard of leadership and competency in the promotion of sound conservation practices. Over the past 5 years, the Village has conducted energy savings audits to determine what types of lighting & HVAC projects are eligible for grant monies through DCEO. "The awarding of this grant is yet another example of how this and other similar initiatives are not only good for the environment but also saves tax dollars", said Village President James Chmura.

#### **COMMENTS FROM THE PUBLIC:**

Sheldon Berger

- Under the President's Report regarding runway rotation, does that mean runways will not be demolished? There was discussion regarding the SE-NW run way being decommissioned. Short response from President Chmura.
- Is it Ace Hardware that will be selling guns? What exactly will they be able to sell? Will
  they do any gun repairs? How many dealer licenses in the Village are there right now?
- Under Police item (b) Solicitors permit issued today however they were at his home yesterday. How is approval given to applicants? Should they be out before the board vote's approval?

Public Works – The paving on Overhill's north half of the 4100 block is fine the south half
is still crumbling including the temporary patch work. Nothing has been done since he last
mentioned this.

Short responses were given to each of Mr. Berger's comments.

Joe DiGiovanni

Mrl DiGiovanni had a concern with the property at 4013 Osceola. It has recently been sold and new owners were doing renovations. Garbage has been piled in the yard, a fence was extended to the back of the property and they are parking on the property off the alley. He has asked nicely to have it maintained and nothing was done. He asked the board to look at the property and address the concerns there.

Colleen Lizak

Ms. Lizak voiced a concern with the zoning request for selling rifles and hand guns in the village. As a retired school teacher who has seen the effects of gun violence first hand she strongly opposes this decision by the board. Teachers now have to teach students what to do in a lock down situation which includes hiding in closets and blocking the doors. What is the value of selling guns in Norridge? She has never heard of anyone looking for guns in town. What about the safety of residents? Will there be any training or security involved with allowing for this decision to sell?

Mary Walsh

Ms. Walsh stated she agrees with statements made by Ms. Lizak. Neighborhood store selling guns is not appealing. She is disappointed in both the zoning and village boards approving this. The store will be losing two good customers.

Responses were given by both Mark Chester, Village Attorney and President Chmura.

After comments from the public were completed, President Chmura mentioned a dilemma he was in. He ordered a case of wine to give each of the Trustees. Instead of getting one case he received one bottle. He decided to give it to his favorite trustee and brought it to Dominic Sulimowski.
