Wayne Jarosz

Mr. Jarosz has experienced challenges with his neighbor. He has filed police reports and is taking legal action. His neighbor currently parks ladder rack trucks on the street. They are there overnight and take up a good portion of the block. He also stores work materials in the backyard. The property is being used to run his business which there are ordinances against.

Parking on the street is the greatest concern. He has to park his own car in the front of his house and then move it after midnight when his wife gets home so she does not have to walk down the block alone. A business truck is ok however the current situation is excessive. Mr. Jarosz wanted his concern to be known by the board.

President Chmura gave a brief response encouraging Mr. Jarosz to call police so challenges are logged.

In regards to the challenges with parking on her block, she is concern with getting home late at night. There have been days she has parked 2-3 blocks from her house and had to walk. Her safety is at risk.
