Harlem Avenue, which are currently zoned "B-2" Restricted (Shopping Center) Business District to "B-3" General Business District, hearing held on October 3, 2016, Case No. 610.

Oketo Avenue, hearing held on October 3, 2016, Case No. 613.
- (c) Accept and adopt the Plat of Consolidation approved by the Plan Commission and the Village Engineer in regards to the property located at 8032 W. Giddings Street, which previously had two PIN numbers assigned and was consolidated to one PIN number.
