# LAW & ORDINANCE & ECONOMIC DEVELOPMENT, Trustee Falagario:

Trustee Falagario asked President Chmura to review his discussion item.

As Liquor Commissioner, President Chmura explained the ownership of Miska's Liquors has changed. The new owners, Mehul Patel and Mamesh Pandya, have gone through the application process and background check and will receive a class B liquor license. This is not a transferred license from the former owner. The former owner gave their license up and the new owners applied.

# WATER, UTILITIES, IT, CELL PHONES, CELL SITES and ELECTRICAL AGGREGATION, Trustee Sulimowski:

Trustee Sulimowski mentioned:

(a) As a matter of record: The City of Chicago advised us via letter dated March 1, 2017 that beginning June 1, 2017 the water rate shall increase \$0.07 per 1,000 gallons. This reflects a 1.83% increase. The City references the Consumer Price Index inflation rate for 2016 being 1.83%. This letter will be reviewed by the Water and Finance Departments and an analysis by the Village of Norridge will be conducted.

Trustee Sulimowski asked if there were any questions in regards to his consent agenda. There were none.

### POLICE, Trustee Kucharskí:

Trustee Kucharski introduced Sherrill Ornberg, a consultant for the newly created Municipal Consolidated Dispatch (MCD). Ms. Ornberg gave a presentation regarding the soon to be consolidated Norridge, Harwood Heights and Schiller Park 911 dispatch center.

Ms. Ornberg explained her role in the consulting process for the consolidation. The State of Illinois passed a new law requiring municipalities under 25,000 residents to consolidate their 911 dispatch centers. Ms. Ornberg has worked with many municipalities across the state and complimented the group representing Norridge, Harwood Heights and Schiller Park. They come prepared for meetings, they think about the impact on residents and work well together.

In regards to Norridge dispatchers all have tested and passed the requirements to serve as a dispatcher in the new center. They will move to oral interviews. All will be ranked based on their interviews and hired in order.

The final phase is to identify the best Executive Director to run the center. Four candidates have gone through the oral interviews. Three of the four remain. They will move on to psychological tests as well as leadership evaluations.

The center will staff 18 dispatchers with an annual budget of \$2 million.

Ms. Ornberg asked the board if there were any questions.

President Chmura asked for a time frame as to when we can expect the center to open. The group had hoped to open by the end of June however the telephone contractor asked for a 30 day extension. The anticipated day is now the end of July 2017.

Trustee Sulimowski asked if any of the candidates for the Directors position were from the local communities. The answer is No.

Trustee Kucharski had no other discussion items. She asked for any questions in regards to her consent agenda.

Trustee Sulimowski asked that she motion each item separately as he would be abstaining from a vote for item (b).

Trustee Kucharski asked President Chmura and the board to:

(c) Accept letter dated March 15, 2017 from Police Chief David Disselhorst recommending that Michael F. Caravia be appointed to the position of full-time Probationary Police Officer, effective April 1, 2017, at a starting annual salary of \$60,335.18.

President Chmura appointed Michael F. Caravia as a full-time Probationary Police Officer, effective April 1, 2017, at the annual salary of \$60,335.18.

(d) Concur with the President's appointment.

Kucharski, Sulimowski, Falagario, Gregorio, Gelsomino Yea. Nays none. Motion carried.

Clerk Budnik administered the Oath of Office to Probationary Officer Michael F. Caravia.

President Chmura stated it is good to see progression from a "local boy" Officer Caravia previously worked as a traffic aid in Norridge, auxiliary police officer in Norridge and Police Officer in Itasca before his return to Norridge. It is great to see the progression and success from former employees.

# VILLAGE PROPERTIES, HR, INSURANCE and ENVIRONMENT, Trustee Gelsomino:

Trustee Gelsomino mentioned:

(a) The Village's broker is currently bidding out the Village's health, dental and disability insurance policies and will be making a recommendation to the Village Administrator and HR Committee before April 30, 2017.

Chief Disselhorst a number of years ago was asked to not run for re-election as it could be a conflict with his role as a police officer.
