## Case 604 – Tetiana Sinclair, 4701 N. Cumberland Ave., Unit K2

TETIANA SINCLAIR (Renter) - PRESENTED THE CASE FOR THE REQUEST FOR A SPECIAL USE UNDER THE REQUIREMENTS OF ARTICLE X, B-3 GENERAL BUSINESS DISTRICT, SECTION 5 – SPECIAL USES OF THE ZONING ORDINANCE OF THE VILLAGE OF NORRIDGE – 1962; FOR THE PURPOSE OF OPERATING A PERMANENT (TATTOO) COSMETIC (MAKE-UP) BUSINESS ON THE ABOVE PROPERTY.

Tetiana Sinclair stated that she will only apply permanent make-up to the face of her customers (eyebrows, eyeliner, lips). She explained that permanent make-up only lasts two years unlike tattoos last forever. She uses only permanent make-up.
