Special Board Meeting of May 8, 2019.

All current Trustees were present at the Special Board Meeting of May 8, 2019 and eligible to vote on the second motion.

President Chmura had nothing for his President's Report.

The meeting was opened for public comments.

#### Louise McMahon

80 years ago one of the reasons her parents moved to Norridge was to enjoy the open green space. She asked the board reconsider the idea to disregard the zoning ordinance that would eliminate some of the green space for higher investments.

The City of Chicago has built continuous condos in their green space. That is not what Norridge should be looking for. Keep the green space.

#### Michelle Feola

Ms. Feola is an attorney with Fuchs & Rosseli. The firm was contacted by concern residents regarding Ordinance 1954-19.

Regarding the zoning hearing that occurred April 8, 2019, concern because the required notice was not given to some residents. On May 20 a letter of affidavits from residents of Norridge and Chicago was put together stating they did not receive notice of the request to appeal the current ordinance. Not receiving proper notice raises concerns with due process.

The Village cannot proceed with a hearing without requisite notice. Her clients are asking to postpone this evenings vote and send the matter back to the Zoning Board for a proper hearing. Current situation is a violation of due process and of the Village's own ordinances. Please do not rush your judgement this evening.

#### Flo Wawczak

We recycle to save the Earth and our environment yet we want to allow for a gas station. She feels bad for residents that live near the location. There is a concern of the crime that may now come into play. Health is more important than the money being brought in by a gas station.

#### Lin Cowsky

What addresses received letters for the zoning hearing?

Brian Gaseor responded that the code requires notices be given 300 feet from the property. That is estimated to be 6-8 homes.

Ms. Cowski asked if that should be larger. Three houses are For Sale on that block. Does anyone want to move to that area? That will hurt the value of the homes. She was mentioned in the newspaper about calling 911 to report license plates. She did not call 911 to report plates. She called the non-emergency number and was asked to go outside to get the license plate of the car parked in the accessible parking spot. From now on she will call 911 with all concerns including those related to a gas station.

#### Marlene Los

She lives at 4017 Overhill and never received a certified letter form the Village regarding the zoning and proposed gas station.

## Mary Willard

Was there a sign on the property giving notice to the hearing? She drives by every day and did not see it. Residents further than 300 feet should be notified. They do not want the gas station. Village should consider what other purposes the property could be used for.

#### Jeff Wawczak

He agrees with the people that lived through the last gas stations that were built. If you lived through other stations being built and it was challenging, why vote for another one to be built? This will invite more problems and create more traffic issues.

#### Jan Horn

She has been a resident for 51 years. From 7:30 AM Monday through Saturday Cresent changes from a residential street to a commercial street. Residents are disturbed by businesses being run out of homes. One is a landscaping business and one is heating and air. The street is not zoned commercial however this has been allowed and continues. Why? She also asked that the village take a look at a sink hole in the middle of Cresent near 4851. It seems to be getting larger.

President Chmura responded he will have both matters addressed.

#### Manuel Hernandez

Mr. Hernandez works the night shift. The 24 hour stations attract the wrong people. He sees it and has concerns. The homeless can also be seen hanging around those stations. Officers can monitor but they have other things to be monitoring as well.

### Daisy Aguilera

She has been in the Village for over 20 years. She has raised her children here. It used to be a green neighborhood. There are flooding issues now that will create more when the green space is gone. She is worried about gas running into the ground and the homes. Environmental studies would help all residents not just those 300 ft away. Residents will see gas on water. Study is needed so residents can know the impact.

There were no other public comments. The meeting moved to committee reports.
