FINANCE, LICENSES & CONTRACTS, Trustee Gregorio:

Trustee Gregorio mentioned:

(a) The annual Treasurer's Report for Fiscal Year ended April 30, 2019 was published in the October 17. 2019 edition of the Norridge Harwood Heights News. A copy is posted

on the lobby bulletin board and is also available on the Village's website.

(b) As a matter of record, the first payment on the \$1,500,000.00 line of credit obtained from Wintrust Bank was made on October 15, 2019. Total payment was \$89,536.84 (\$63,286.84 in principal and \$26,250.00 in interest). Going forward, payments are due twice each year, May 7th and November 7th. The line of credit will be paid off May 7, 2029.
