## **President's Report**

President Tannhauser asked for a motion to accept his recommendation for assignments for the remainder of Fiscal Year ending April 30, 2020.

### Comments from the Public.

Michael Holzer

Mr. Holzer is a resident of Harwood Hts. His daughter attended Union Ridge and Ridgewood High School. He is familiar with the schools in the area. Good news for Norridge, his daughter recently moved from Harwood Hts to Norridge. Bad for him as he now drops his grandson at Leigh which is 2 ½ miles from his home not 2 blocks like Union Ridge.

The layout for drop off and pick up there is a mess.

Kids are too young to get to school on their own and some of the adults that drop off are too old to follow the process for drop off and pick up which means having to park blocks away and walk to the entrance.

Other schools have a one way street by the entrance. His daughter teaches in Oak Park and he picks up his granddaughter twice a week from there. Oak Park has one way streets. Union Ridge has a one way street and also includes a curb side drop off.

Leigh allows cars on both sides of the street with drop off on both sides allowing some kids to be dropped off in the street.

Current process makes no sense.

Something needs to be done as the situation is dangerous. Consider making Courtland one way going north bound from Eastwood on the south to Lawrence on the north. Are there options for Giddings to be one way? Something else needs to be done.

School also needs to look at where crossing guards are currently positioned.

They should stand at streets with cross walks not at locations where kids do not cross. Please fix the dangerous situation out there.

Wally Biszcuk

Mr. Biszcuk agreed with Mr. Holzer and added he does not see police at the school with all the traffic concerns.

Why is public works cleaning Divine Savior Church instead of doing the streets and alleys in Norridge. The streets should be cleaned before school. Public works should not be cleaning the church.

Leigh school is grades 1-4 with small children. He never sees anyone from the Village at the school events. Village should attend school events.

Public works should clean the streets and alleys not do charity work for the church.

#### Kathleen Smith

Ms. Smith is back to ask the Village to reconsider her request to pay for the damage caused at her house a few weeks ago by the SWAT team. She has receipts for \$1200 from damages to her windows. How can the Village help? She feels the damage done by the police was excessive. She is a single parent with a terminal son that made a bad decision. Asking for help.

Anna Milera
The drop off and pick up at Leigh school is a huge problem. There has to be a way to make it work. The sidewalks are not cleared adding to the traffic concerns. Consider doing something for the school. She is a 20 year resident and this situation is a disaster.

Gus Rappatas

He is also concern with plowing being done at Divine Savior. Why does the Village do it?

President Tannhauser commented the Village has an unwritten agreement with them which in turn for plowing allows us to use the property for snow piling and other needs.

Mr. asked if the need to levy taxes is ever going to end. There was a levy last year and now again this year. He thought the Village made a contribution to the fund in the past. Where has

### that money gone?

Joanna Skupien shared that in 2014 the Village contributed \$27,000, in 2017 \$50,000 and in 2018 \$100,000. The levy reviewed this evening was from 2018 for \$2.1 million. An increase was needed to catch up. Rather than a large percentage all at once the Village split the increases taking \$1.9 million last year and \$2.1 million this year. Next year is estimated to be about 5%. Funding pensions is mandated by the state.

Mary Willard

Thanked the Village for plowing her alley. In the past that was not always done but does get done now.

In regards to Divine Savior, the church does not allow residents to park in their lot. If the Village is going to continue plowing their lot then residents should be able to park in the parking lot.

#### Maria Lala

Two years ago she came to a meeting to complain about the traffic on Oketo. A study was supposedly being done to help with the excessive speed and traffic on the street. The residents have not heard a thing since. President Chmura promised to fix the problem however nothing has been done. The Police Chief told her they would be out there. Nothing is happening on Oketo. Stop signs are on every corner. Traffic is worse.
