### TRUTH IN TAXATION PUBLIC HEARING - PROPOSED TAX LEVY

Clerk Budnik read the notice published in the Pioneer Press/Norridge and Harwood Heights News October 31, 2019, regarding the Truth in Taxation Public Hearing in regard to the Proposed Tax Levy to fund the Village share of the Police Pension Fund for the fiscal year May 1, 2019 to April 30, 2020.

A brief presentation was given by Lauterbach & Amen, LLP. Last year the Police Pension Fund was 55.7% funded. This year estimate is 56.06% with the recommended contribution of \$2,117,467.00. The 56% funding is average for the State of Illinois.

The benefit accrual for active members is 20% of the fund.

The unfunded liability is \$21.7 million or 80%.

If payments continue on a path of exceeding the fund liability, the unfunded portion should decrease. Current projections have the fund 100% funded by the year 2036.

President Tannhauser opened the hearing for public testimony, public comments, questions and suggestions. There were none.
