# PUBLIC WORKS, TREE PROGRAM, PARKING, STREET LIGHT CABLE REPLACEMENT PROJECT: Trustee Larson:

(a) An ordinance is in the process of being prepared memorializing the snow route parking changes which will go into effect for the 2020/2021 winter season. Once the Board approves the ordinance, we will communicate the changes to the public.

(a) Approve the request of Mrs. Wendy High, on behalf of School District 80, to hold a caronly parade, covering a portion of the District's boundaries, in lieu of traditional end of year activities, due to the school being closed given the pandemic situation. Cars will assembly at the Salvation Army (permission granted) at 10:00 AM on Friday, May 29<sup>th</sup>. Parade to start approximately 11:00 AM and will include approximately 60 cars. The rain date shall be June 1, 2020. Route map was submitted with the request.

(b) Approve the request of Pat Rossi, on behalf of Ridgewood High School, to hold a drive-by graduation on June 23, 2020, with assembly at the AMC Parking Lot (assuming approval is received). The event will take place on RHS grounds; only the procession of graduates coming from the AMC to RHS will result in increased street

traffic.
