Clerk Budnik announced the results of the April 6, 2021 Consolidated General Election as Certified by the Cook County Clerk.

The Village of Norridge has 9,894 registered voters. There were 3,193 ballots cast which is a 32.7% voter turnout. Final results certified April 27, 2021:

There were no public comments.


Motion by Gelsomino, seconded by Larson that, there being no further business, meeting be adjourned at 6:42 p.m.
