Trustee Bielak stated that regarding consent agenda (c) a Yes vote is to NOT CONCUR with the Zoning Board's recommendation.

Trustee Budnik asked if it was made clear to the Zoning Board why we did not approve the first response from the Zoning Board?

Trustee Bielak responded that when we received the first recommendation from the zoning board, the village board neither approved or denied the request. It was sent back for further review with the hope that the applicant would provide further details as to the project and its

impact on the surrounding area.

Trustee Budnik also asked if other items from the petitioner were addressed and of concern with the board and if we will be clear with any concerns this time if the board again does not agree with the Zoning recommendation.

Trustee Bielak stated that the petitioner did mention that the hours of operation were being adjusted from 24 hours to a shorter period and that further details were provided as to the noise wall but that there was not enough effort to conform to current zoning standards or show that effort was made to work with the next door neighbor to satisfy his concerns regarding the change in the use of the property. When the project was sent back for further review the hope was that there would be significant effort made to provide more detail and better show that all options were examined before recommending this option.

MOTION: by Trustee Bielak, second by Trustee Ronstadt to:

(c) NOT CONCUR with the recommendation of the Zoning Board of Appeals and DENY the petition of Haresh Patel, requesting that the property located at 4750 North Ozanam Avenue be rezoned from R-1 Single Family Residence District to B-2 Restricted (Shopping Center) Business District and furthermore requesting a Special use for a Drive-Thru as part of the existing Donut Shop at 7801 West Lawrence Avenue along with Parking Area Set Backs from the Zoning Ordinance of the Village of Norridge, hearing held on December 7, 2020 and on March 1, 2021, Case No. 646.

Trustee Gelsomino asked if anyone spoke to Mr. Patel?

Trustee Bielak replied that yes Brian reached out to Mr. Patel after the case was sent back for review with comments regarding his presentation and design.

Trustee Bielak stated that he is supportive of the project in concept but is not supportive based on how and what was presented in the two hearings.

POLICE, Trustee Budnik:

Trustee Budnik presented an update on the position of the Chief of Police:

Received 59 timely applicants.

ACS is reviewing to ensure the applicants have met our criteria for applying.

• Those that have met the criteria will be sent a written exercise in early July and applicants have five (5) days to complete it and email back.

 Round 1 of interviews should be 3rd or 4th week of July. This round will narrow down our list of candidates to potentially 3-5.

Round 2 of interviews should be in early August.

• Committee would like to make a conditional offer to the TOP candidate mid-August.

Trustee Budnik also stated she would like to have on record the increase in motor vehicle thefts/burglaries in the Village.

Catalytic converters thefts – these parts contain precious metals that can be scrapped for \$150-\$200. Since May 1, 2021 there has been a spike in catalytic converter thefts in Chicago and areas around us. Norridge has seen 7 since May 1st.

Car Hopping – which we have mentioned in the past. Typically, teens or young adults checking for unlocked car doors to steal items of value from the inside.

The Police Department is well aware of the activity around us and have begun saturating areas where large amounts of vehicles are parked.

A Robo call will go out at the end of the week to notify residents of these crimes and to ask them to not only be vigilant but call 911 to report anything that seems suspicious.

Trustee Budnik also thanked the Police Department for their services.
