LAW & ORDINANCE & ECONOMIC DEVELOPMENT, Trustee Bielak:

Trustee Bielak had no discussion items for review. He asked if there were any questions regarding his consent agenda.

Trustee Budnik asked in regards to item (f) if there will be a follow up system/process in place to verify all requirements and that residents adhered to those requirements. If a dog is dangerous how do we know if resident is following the protocol and how do we know if a resident moves or gets rid of the animal? How do we know if owners are following the protocol?

Trustee Bielak – Yes if the ordinance is passed by the board here tonight the next step in the process would be working within the police department to ensure that the new ordinance that is passed is followed closely and a procedure is set up for that department. The dog's owner goes through adjudication court and that record for the dog stays with the owner as they move.
