AN ORDINANCE AMENDING CHAPTER 94, ARTICLE IV, DIVISION 1, SECTION 94-190 "RESIDENT PARKING ONLY", AND SECTION 94-196 "PROHIBITED [PARKING] IN SPECIFIC LOCATIONS AND TIMES" ENACTING SUBSECTION J "OVERNIGHT PARKING" AND AMENDING CHAPTER 38, SECTION 94-190 OF THE REVISED MUNICIPAL CODE OF THE VILLAGE OF NORRIDGE – 2002 ENACTING CERTAIN VILLAGE WIDE OVERNIGHT RESIDENT ONLY PARKING RESTRICTIONS AND ASSOCIATED FEES

An Ordinance Enacting Village Wide Overnight Parking Restrictions on Village Streets, Amending Resident Annual Guest Parking Pass Regulations and Fees, and Enacting Regulations for Temporary Parking Permission on Village Streets

WHEREAS, the Village of Norridge ("Village"), as a home rule municipality in accordance with Article VII Section 6(a) of the Constitution of the State of Illinois of 1970, is enacting this Ordinance providing for the protection of the health, safety, and general welfare of the Village of Norridge; and

WHEREAS, it is the policy of the Village to provide protection for the public health and safety by regulating the parking of motor vehicles on municipal property within its borders; and

WHEREAS, Chapter 94, Article IV, Division 1, Section 94-196 of the Revised Municipal Code of The Village of Norridge – 2002 ("Code") provides for parking restrictions; and

WHEREAS, Village staff have recommended that it is necessary to enact "no parking" restrictions on all streets in the Village from 2:00 A.M. to 6:00 A.M. daily, excepting only those vehicles that have a valid Village sticker and valid state registration or an annual guest pass or temporary Village parking permission, and these restrictions are set forth in an amendment to Chapter 94, Article IV, Division 1, Section 94-196 by the enactment of Chapter 94, Article IV, Division 1, Section 94-196 subsection J entitled *Overnight Parking*; and

WHEREAS, Village staff have also recommended modifications to Chapter 94, Article IV, Division 1, Section 94-190 of the Code entitled *Residents' Parking Only* regarding resident parking only on certain designated Village streets, and to provide for two (2) free annual guest passes and two (2) additional annual guest parking passes at modest cost to permit guest parking on residential Village streets that are currently designated for *Residents' Parking Only* in current Section 94-190 C. and *Restricted Resident Permit Parking* in current Section 94-190 D., to those corresponding changes to Chapter 38, Section 190 of the Code; and

WHEREAS, the proposed amendments and additions to Chapter 94, Article IV, Division 1, Section 94-190 will require the subsections of that portion of the Code to be relettered as set forth hereinbelow; and

WHEREAS, the Village Board of Trustees has determined that it is necessary to enact the parking restrictions set forth herein and install any appropriate signage indicating the parking restrictions and that these restrictions are in the best interests of the health, safety and general welfare of the Village.

NOW THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Norridge, Cook County, Illinois:

Section 1.

The facts and statements contained in the preamble to this Ordinance are found to be true and correct and are hereby adopted as part of this Ordinance.

Section 2.

That Chapter 94, Article IV, Division 1, Section 94-190 of the Revised Municipal Code of the Village of Norridge – 2002 be and hereby is amended as follows:  
amending Subsection A by transferring the requirement of a valid Village vehicle sticker from current Subsection B *Definitions* into current Subsection A *General Restrictions* and redrafting the exceptions to Subsection A; amending the definition of “Resident” in current Subsection B *Definitions* to remove extraneous regulatory material; enacting a new Subsection C *Guest Parking on Designated Streets* amending and providing for annual guest parking passes in locations designated for resident only parking;  
amending current Subsection C *Resident Only Parking* for certain streets to correct scrivener’s errors in the spelling of certain streets, removing Carmen Avenue, Denal Avenue, Knight Avenue, Octavia Avenue, and Ridgewood Avenue from the chart in Subsection C (now Subsection D) as restricted parking on the aforementioned streets is continued as restricted parking elsewhere in this in Code Section 94-190 and in Chapter

94, Article IV, Division 1, Section 94-196, and relettering current Subsection C to be Subsection D; amending current Subsection D and relettering it as Subsection E *Restricted Resident Permit Parking* to provide for annual guest parking passes for certain residential streets with restricted resident permit parking; and enacting a new Subsection F providing for temporary guest parking permission for streets designated in Section 94-190. These amendments are set forth hereinbelow as follows:

**Chapter 94 - TRAFFIC AND VEHICLES**  
**ARTICLE IV. - STOPPING, STANDING OR PARKING**

**Sec. 94-190. Residents' parking only.**

A. *General restrictions.* No person shall park any Private Passenger Vehicle (as defined herein) at any time on those portions of the residential streets listed in Subsection D. of this Section 94-190 A, unless:

1. the vehicle displays a valid Village of Norridge vehicle license sticker pursuant to Chapter 94, Article VI. – *Vehicle Licenses* of this Code; and,
2. the vehicle has a valid state vehicle registration pursuant to Chapter 94, Article IV, Division 1, Section 94-201 – *Valid State Vehicle Registration Required For Parking* of this Code; and
3. the vehicle is registered (state registration) to an address in the Village of Norridge; or
4. the vehicle displays a valid annual guest parking pass that is fully compliant with the annual guest parking regulations set forth in this Code in Chapter 94, Article IV, Division 1, Section 190 – *Residents' Parking Only*; or
5. the vehicle has obtained permission issued by the Village to park overnight in a specific location. This permission is on a temporary basis only; and
6. unless restricted or prohibited elsewhere in this Chapter 94.

Every resident of the Village of Norridge must display a valid vehicle sticker on his or her vehicle, regardless of where the vehicle is parked within the Village. Village residents may not display a guest parking pass in lieu of a valid Village vehicle sticker.

B. *Definitions.* The following words, terms and phrases, when used in this section, shall have the meanings ascribed to them in this subsection, except where the context clearly indicates a different meaning:

*Guest* means any person who visits or calls upon a resident of the Village, but does not stay or reside in such abode beyond the limits established by the state statutes and/or this Code regarding registration or licensing of the guest's vehicle.

*Private passenger vehicles* means, but is not necessarily limited to, automobiles, motorcycles, motorized conveyances, passenger vans and certain trucks and recreational vehicles which are owned, leased, rented or borrowed by residents of the Village.

*Resident* means any person who owns, leases, rents or otherwise occupies an abode within the corporate limits of the Village for some portions of each calendar year, but such status may be claimed only during the actual term of each occupancy.

C. *Guest Parking on Designated Streets.* Residents of Norridge who live on blocks designated with resident only parking signs may obtain 2 free annual parking passes and can purchase up to 2 additional annual guest parking passes. Guests are not permitted to park on streets restricted to resident parking only unless they have a valid, current, annual guest parking pass issued by the Village or have been approved by the Village for temporary parking permission. The fee for the additional annual guest parking passes is set forth in Chapter 38, Section 94-190.

D. *Resident only parking.* Resident only parking shall be on the following streets:

Ainslie Street	North side of street between Cumberland and Delphia Avenues.
Ainslie Street	South side of street between Delphia and Clifton Avenues.
Argyle Street	South side of the street between Delphia and Cumberland Avenues.
Argyle Street	Between East River Road and Leonard Drive on the north side of the street.
Chester Avenue	Between Argyle and Ainslie Streets.
Chester Avenue	4800 block on both sides of the street.
Foster Avenue	8300 block on the south side of the street, from 8301 W. Foster west to Cumberland Avenue, inclusive.
Giddings Avenue	8200 block, both sides—6:30 a.m. to 3:00 p.m., Mondays through Fridays.
Greenwood Avenue	Between Argyle and Ainslie Streets.
Leonard Drive	5000 block bounded by Argyle and Carmen on the east side of street.
Leonard Drive	5000 block bounded by Argyle and Carmen on the west side of street.
Montrose Avenue	7300 block on the south side of the street, Monday through Friday.
Odell Avenue	4000 and 4100 blocks on both sides of the street.
Oriole Avenue	4000 block on both sides of the street.
Ottawa Avenue	4000 block on both sides of the street.
Overhill Avenue	4000 block on both sides of the street.
Overhill Avenue	4600 north to 4724 north and from Giddings north to the public alley, on the west side of the street (from Memorial Day to Labor Day).

Overhill Avenue	4500 to 4553 north, on both sides of the street (from Memorial Day to Labor Day).
Ozark Avenue	4000 block on both sides of the street.
Wilson Avenue	7700 block on both sides of the street (from Memorial Day to Labor Day).
Wilson Avenue	On the South side from Oriole Avenue to Overhill Avenue (from Memorial Day to Labor Day).

E. *Restricted resident permit parking.* Restricted resident permit parking shall be allowed on the following streets:

1. Cullom Avenue: North side of Cullom Avenue only from the alley west of Harlem Avenue then west to Octavia Avenue. South side of Cullom Avenue between Octavia Avenue and Harlem Avenues for a distance of 270 feet east (measured from the east curb of Octavia Avenue (extended)). Parking in these designated areas of Cullom Avenue is restricted to only those residents of this designated section of Cullom Avenue holding valid Village-issued permits therefore.
2. Octavia Avenue: West side of Octavia Avenue from the first alley north of Irving Park Road to Cullom Avenue. Parking in this designated area is restricted to only those residents of this designated section of Octavia Avenue holding valid Village-issued permits therefore.

Annual guest parking passes for the streets listed in this Subsection E shall be available in the manner and amount set forth in Subsection C hereinabove.

F. *Temporary parking permission.* Vehicles needing temporary overnight parking permission shall obtain such permission from the Village.

### Section 3

That Chapter 94, Article IV, Division 1, Section 94-196 of the Revised Municipal Code of the Village of Norridge – 2002, providing for parking restrictions in specific locations and times be and hereby is amended by the enactment of Section 94-196 Subsection J *Overnight Parking* providing for parking restrictions on Village streets between 2:00 a.m. and 6:00 a.m. daily, and providing for Village residents to obtain annual guest parking passes or temporary parking permission enabling overnight guest parking as set forth hereinbelow.

**Chapter 94 - TRAFFIC AND VEHICLES**  
**ARTICLE IV. - STOPPING, STANDING OR PARKING**

**Sec. 94-196. - Prohibited in specific locations and times.**

A.

[. . .]

J. *Overnight Parking.* Parking of any vehicle on any public street within the Village, when parking on such street is otherwise permitted, shall be prohibited from the hours of two o'clock (2:00) A.M. to six o'clock (6:00) A.M. daily, unless:

1. the vehicle displays a valid Village of Norridge vehicle license sticker pursuant to Chapter 94, Article VI. – *Vehicle Licenses* of this Code; and,
2. the vehicle has a valid state vehicle registration pursuant to Chapter 94, Article IV, Division 1, Section 94-201 – *Valid State Vehicle Registration Required For Parking* of this Code; and
3. the vehicle is registered (state registration) to an address in the Village of Norridge; or
4. the vehicle displays a valid annual guest parking pass that is fully compliant with the annual guest parking regulations set forth in this Code in Chapter 94, Article IV, Division 1, Section 190 – *Residents' Parking Only*; or
5. the vehicle has obtained permission issued by the Village to park overnight in a specific location. This permission is on a temporary basis only; and
6. unless restricted or prohibited elsewhere in this Chapter 94.

Section 4.

Chapter 38, Section 94-190 of the Revised Municipal Code of the Village of Norridge – 2002 be and hereby is amended by the enactment of the following regulations and fees.



94-190.	Guest parking passes. Two annual guest parking passes per year are available at no charge. Up to two additional annual guest parking passes may be purchased by Norridge residents at the Village Hall for the fee set forth herein. The annual passes expire on June 30 each year.	\$10.00 Each additional guest pass.

Section 5.

If any section, paragraph, clause, or provision of this Ordinance shall be held invalid, the invalidity thereof shall not affect any of the other provisions of this Ordinance.

Section 6.

That all ordinances or parts of ordinances in conflict herewith are hereby repealed.


Section 7.




