#### POLICE, Trustee Budník:

These include payments to 19 Police Department Union employees and 3 Police Department Civilian employees. Payments were made via payroll on the pay date of May 31, 2023.
- (b) Accept letter dated June 19, 2023 from Police Chief Brian Goss and concur with his recommendation that John O'Connor, currently a Probationary Reserve Crossing Guard since October 16, 2021, be promoted to Crossing Guard. Retroactive to April 16, 2023 at the regular rate of \$18.00 per hour, \$55.96 daily crossing rate. John has completed his 18 month probationary period.
- (c) Accept letter dated June 19, 2023 from Police Chief Brian Goss and concur with his recommendation that Karen Valerio, be appointed to Probationary Reserve Crossing Guard effective June 16, 2023 at a crossing daily rate of \$55.96, and hourly probationary training rate of \$16.00. Probation period is 18 months.

(e) Accept the recommendation from Village Administrator, Joanna Skupien to hire Richard D. Thompson, to the position of Part-Time Health Inspector, at an hourly rate of \$21.00. Effective July 5, 2023. Probationary period will be 18 months and he is required to obtain a ServSafe certification within 6 months of hire.

(f) Accept the recommendation from Village Administrator, Joanna Skupien to hire Patrick M. Gorski, to the position of Building Commissioner, at an annual salary of \$75,000.00, with an 18-month probationary period. This position is salaried and has exempt status

under FLSA.
