conflicted with the Ridgewood Board Meeting. After much discussion it was determined that we should move the date back to the original March 3, 2024, date and relocate the meeting to the conference room or the Sieb center depending on the agenda. Mr. Gorski agreed that this would be the recommendation.

Mr. Gorski then briefed the Board about three potential hearings for January:

- 1. Caputo's may have to come in for a setback variance as they put asphalt in an area they should not have.
- 2. The map amendment for the cannabis overlay is set for January.
- 3. There is a request for a hearing regarding the Dunkin Donuts on Lawrence Ave. There was a long discussion which included the sharing of the draft packet submitted. The board made it clear that they did not want to hear a case unless all the proper documentation was submitted and available at the hearing. Mr. Gorski and Ms. Cherry agreed.

Mr. Gorski ended his presentation by wishing Happy Birthday to Norridge as the 75th anniversary was December 4, 2023.

Discussion

Continued work on the proposed new Zoning ordinance. Discussions took place regarding:

- B-3 was modified so all permitted uses from the old "C" were included.
- Norridge Gardens was made a special use by purpose (not owner).
- Above ground floor dwelling chart was approved with the footnote altered to remove the sizes as they are in the chart.
- Added 5.7 to ensure that above ground floor spaces are either all business or all dwellings (not mixed use)
- Approved requiring 2 spaces for all above ground floor dwellings regardless of size.
- Eliminated all "catch-all" language (except in B-4) and will rely on the charts.
- Recommended to remove the "Business District Design Guidelines" from the appendix.
- Drafter's notes are started, but not complete. The goal is to finish them, clean up the draft and submit it in February.
